LOCATION

Blackburn is a rapidly growing and prosperous commuter town located to the North West of Aberdeen. The property will be developed on Site 3C Westpark Business Park, located adjacent to the Blackburn Roundabout on the A96 Trunk Road which connects Aberdeen and Inverness and is the main commuter route serving Aberdeen.

Occupiers at Westpark include Reservoir Group and EV Offshore whilst Micron Eagle, Archer and MTM Construction are located close by. An extremely popular Starbucks Coffee Drive Thru is located immediately adjacent to Site 3C.



DESCRIPTION

The development will comprise a modern, detached retail unit with 14 car spaces adjacent to an Electric Vehicle Charging Station. The subjects are of contemporary design featuring extensive glazing and wil be completed to an agreed specification ready for occupier fit out.
