

LOCATION

1 Berry Street is situated at the junction of Berry Street and Gallowgate in the heart of Aberdeen City Centre. Positioned immediately behind the Bon Accord Shopping Centre and within 100 yards of the MSQ development on Broad Street, 1 Berry Street provides easy access to all the amenity that Aberdeen City Centre has to offer. The exact location is shown on the plan above which has been provided for indicative purposes only.

DESCRIPTION

1 Berry Street provides modern office accommodation arranged around a central core, over ground and three upper floors. The building benefits from comfort cooling and raised access floors in part, perimeter heating and double glazed window fitments. A refurbishment programme is required and the landlord will work with an incoming tenant to refurbish in line with their requirements.

CAR PARKING

Up to 50 car parking spaces will be provided in the Bon Accord Centre Car park at a ratio of approx. 1:505 sq.ft.
