

#### LOCATION

The town of Forres is a wealthy settlement located approximately 12 miles west of Elgin and 28 miles east of Inverness. The town serves an agricultural hinterland and benefits from significant tourism. It is a commuter town serving the larger settlements of Elgin and Inverness. The subjects are situated within the heart of the town, occupiers in the vicinity include Boots, Savers, Co-op and Clear Pharmacy.

## **DESCRIPTION**

The former bank premises comprise part of the ground floor and basement of a three storey and basement stone building, the upper floors are to be converted for residential use.

Internally, the subjects provide retail area together with storage, staff facilities and additional storage at basement level. There is an extensive frontage to the High Street.

The subjects benefit from rear car parking, 5 spaces are included and further spaces may be available subject to negotiation.
